Fake for Real - extended until February 2022


International Forum of Parliament Visitors' Centres

On 18-19 November, the European Parliament, along with the US Capital Visitors Centre, hosted the fourth International Forum of Parliament Visitors Centres. Online for the first time, over 80 representatives from 29 parliamentary visitors' centres discussed their response to the Covid-19 pandemic and shared best practices with colleagues from around the world.

Berlin Wall restoration

The European Parliament has been working to restore two pieces of the Berlin Wall close to the EP campus in Brussels. The original segments, currently located in Park Leopold and on Rue Wiertz, have been restored and enclosed in a protective casing. They will stand next to the visitors entrance of the Hemicycle in Brussels as a reminder of Europe's recent divided




past, and serve as a symbol of the importance of unity over division. The project has been realised in collaboration with the owners of the pieces: the Belgian State and Brussels Capital Region. [Learn more.](#)

A committed European

Andrei Sakharov
Scientist, dissident, human rights activist

Each year, the European Parliament awards the “Sakharov Prize for Freedom of Thought”* named after the Soviet scientist, dissident and Nobel Peace Prize laureate Andrei Sakharov (1921-1989). The popular EP Walking Tours around the European Quarter have ended for 2021: over 1.075 citizens took part in the activity since the launch in May. The [walking tours](#) will return in Spring 2022.
